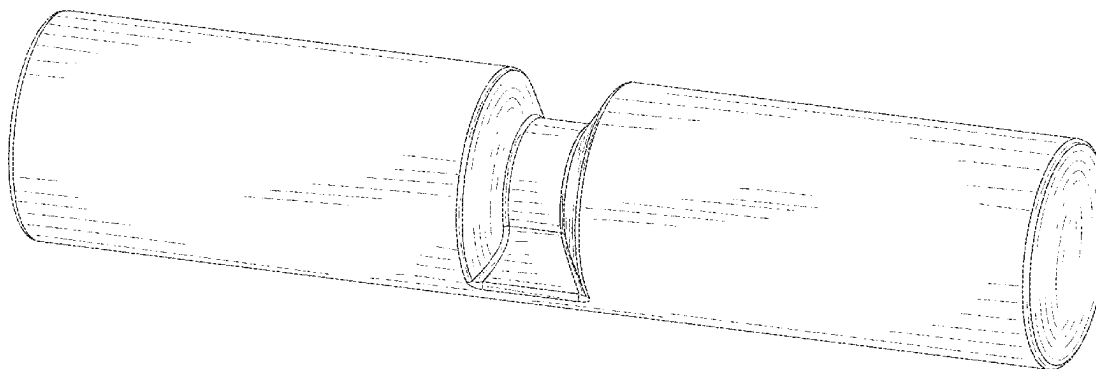
(57) **CLAIM**

The ornamental design for a back roll spinal brace support, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a back roll spinal brace support;

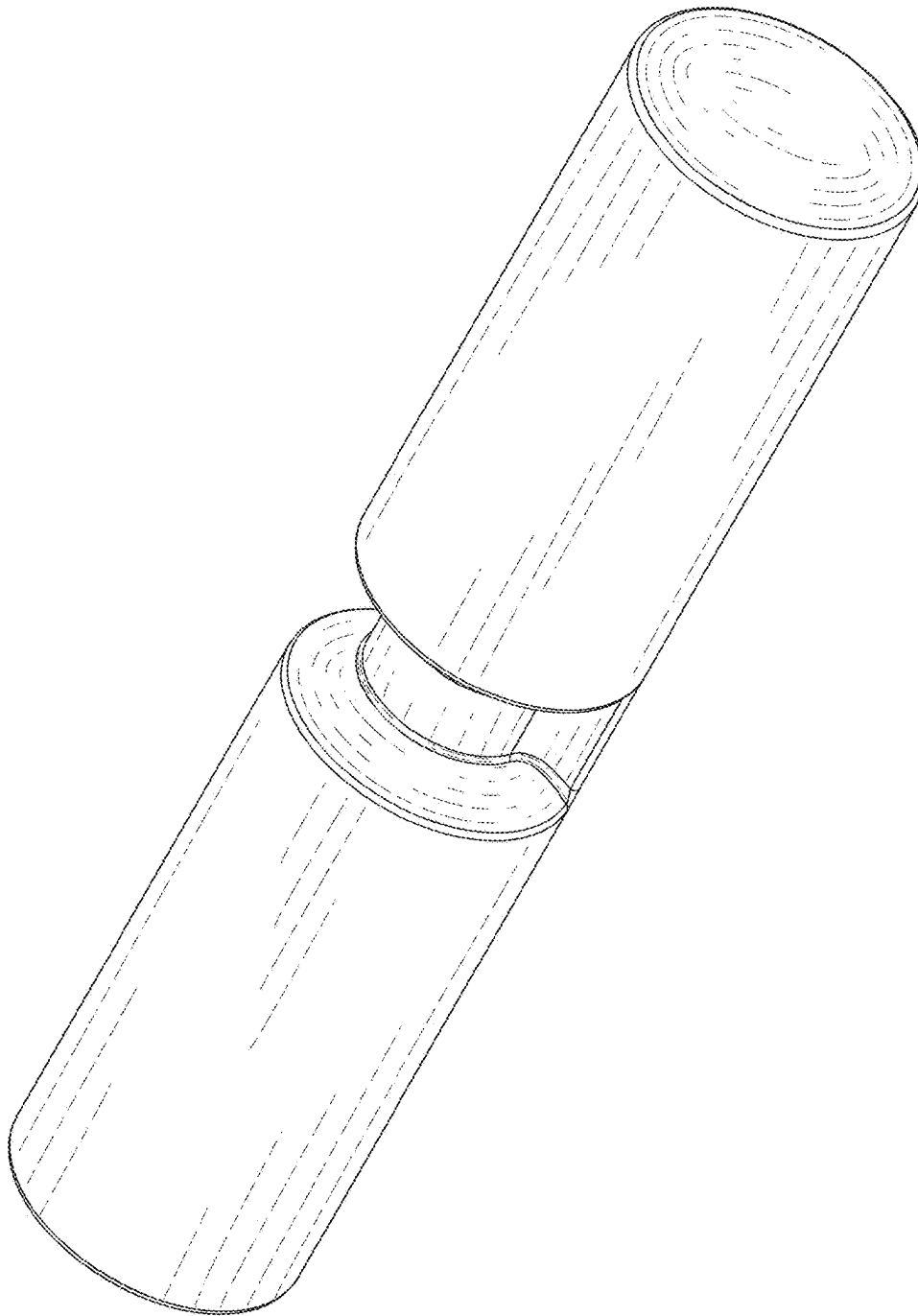

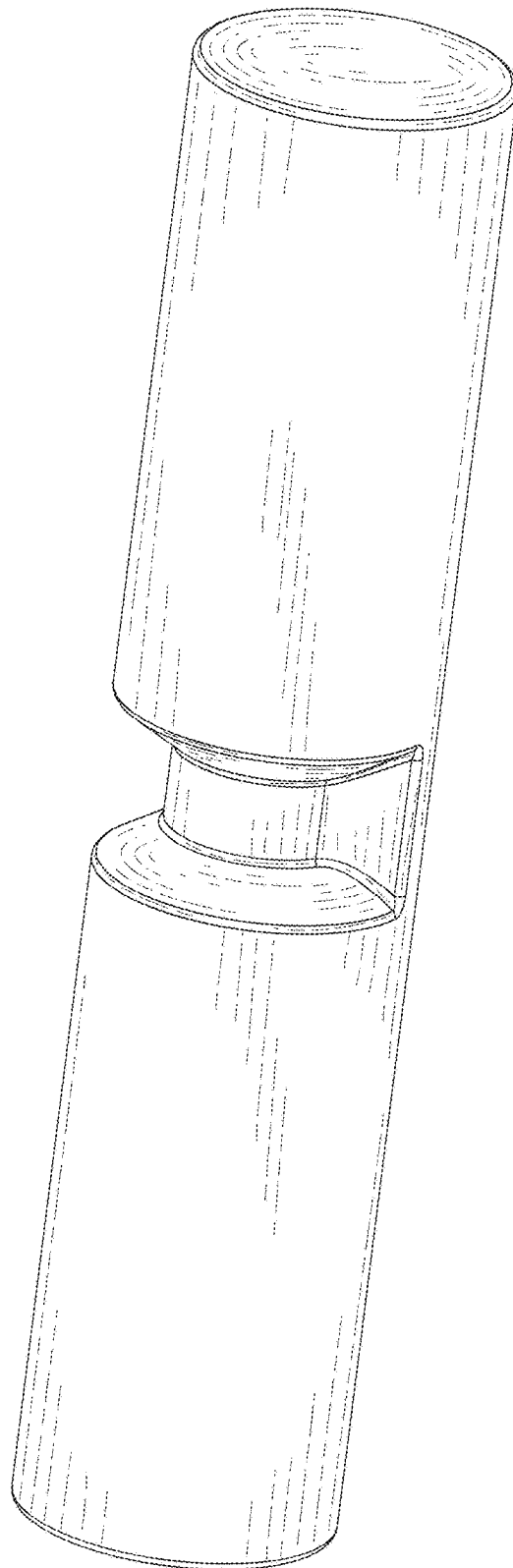

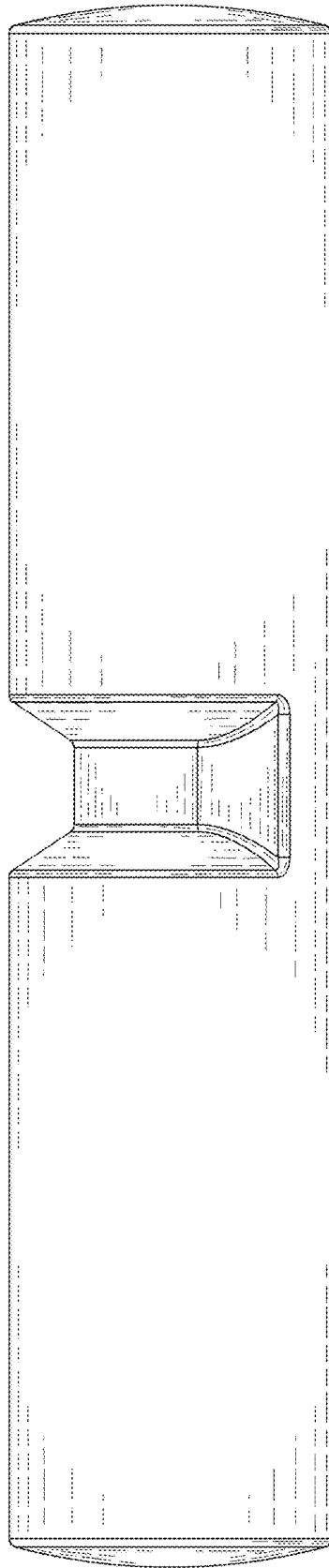

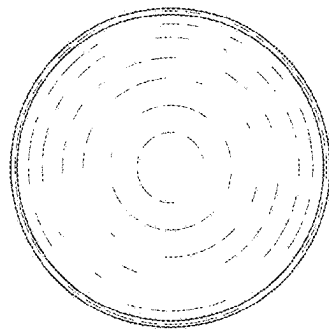

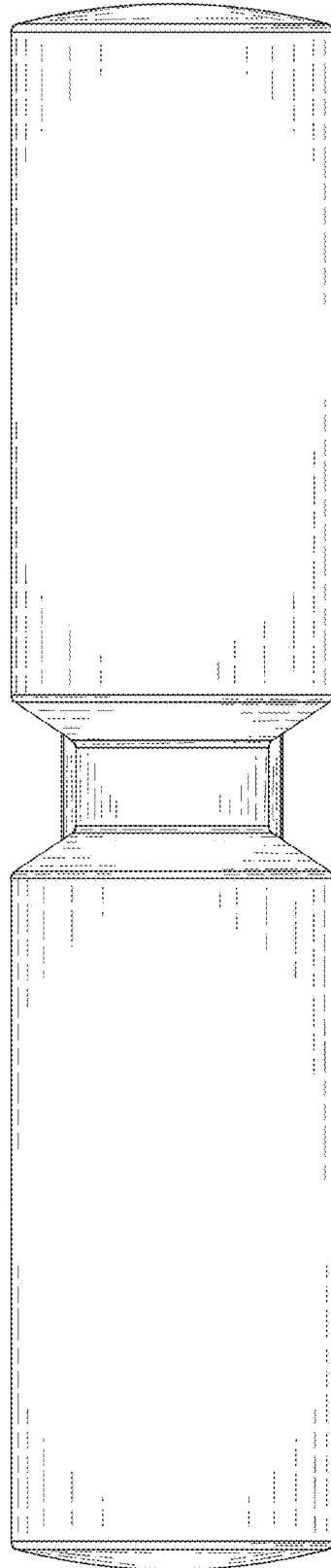

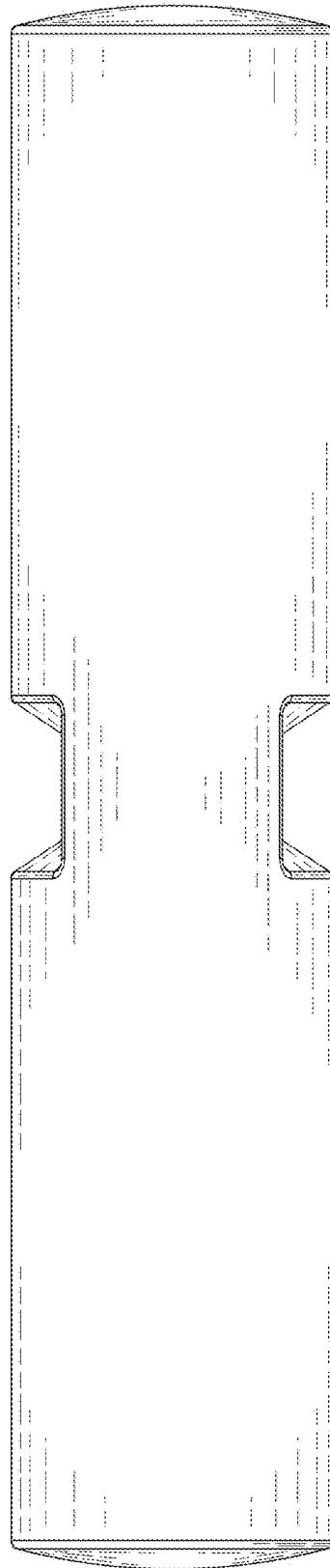
